I, Jennifer Bonzer, swear and affirm as follows:

1. I am an Assistant County Attorney with a duty to prosecute D felonies, misdemeanors, and juvenile matters. I have been with the Webster County Attorney's Office for two years and five months.

2. I met Curt Ruby in connection with my responsibilities. He has been the arresting officer and has testified in a number of cases. He is always well prepared and timely. In addition, whenever I have requested more information or additional investigation, he complies and conducts the investigation requested. Curt returns calls and does what is needed to have a case ready for prosecution.

3. I have prosecuted three matters involving domestic violence in which Curt was involved. In the case of State v. Victor Carlson, Curt was the initial responding officer. The case was tried to a magistrate and Mr. Carlson was found guilty. During the trial, even though Curt was not called as a witness, he stayed at court and watched the trial. He also spoke with the


victim afterwards. I appreciate it when officers do this as there is always a potential for a no contact order violation when the Defendant and victim are in the same area.

4. The second case I recall was State v. Ryan Grossnickle. This was a domestic abuse case. Curt Ruby conducted a thorough investigation providing pictures and the reports necessary to do a prosecution in this type of case.

5. State v. Christopher Kennedy was the third case in which I recall Deputy Ruby being involved. It was a no contact order violation. Curt Ruby sent the case up to me to review and we discussed this matter at some length. To my recollection, we decided there was not a violation and together we decided the better course was not to issue a warrant.

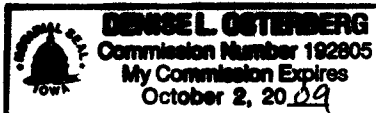
6. Curt Ruby was a good, solid, cooperative, effective law enforcement officer. I have never observed him to be anything but completely professional in his dealings with me and with others.

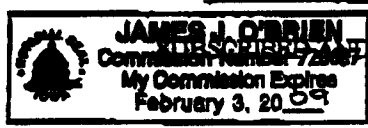


